

## Information about the processing of personal data

<b>Processing goal</b>	We process your personal data provided in the registration form for the purpose of delivering to you, via electronic means, a newsletter ("Newsletter") containing up-to-date information on published periodic reports, current corporate documents, and industry news related to Grupa Pracuj S.A Providing personal data is voluntary, but necessary in order to receive the Newsletter.
<b>Legal basis for processing</b>	The basis for processing your personal data is the consent you have voluntarily given, to the extent and for the purpose specified each time in the content of that consent (Article 6 (1) lit. a of the GDPR).
<b>Processing period</b>	Your data will be processed until we cease providing the Newsletter service or until you properly withdraw your previously given consent. Consent is voluntary and may be withdrawn at any time by contacting us at <a href="mailto:ir@grupapracuj.pl">ir@grupapracuj.pl</a> . Withdrawal of consent does not affect the lawfulness of processing carried out before its withdrawal.
<b>Data recipients</b>	Your personal data may be shared with our authorized employees and contractors, entities we cooperate with to provide the service (e.g., providers of hosting services and IT systems), as well as entities authorized under generally applicable laws (e.g., the police, the prosecutor's office, the President of the Personal Data Protection Office).
