


Scope

This Policy applies to Grupa Pracuj S.A. and all its subsidiaries engaged in operational activities. Its principles cover all aspects of the organization's operations and are binding for all employees, regardless of position, as well as for business partners working with the Group.

Purpose

The purpose of this Policy is to define the Group's commitments to minimizing its environmental impact, managing climate-related risks and opportunities, and adapting to climate change.

Key environmental and climate action areas



Climate change mitigation

- **Operations decarbonization**

The Group undertakes actions to reduce direct emissions (Scope 1) and indirect emissions related to electricity consumption (Scope 2), including modernization of the vehicle fleet and increasing the share of energy from renewable sources, with the goal of achieving net zero emissions by 2050.

- **Sustainable supply chain**

The Group implements Supplier Due Diligence process, including assessment of environmental and climate-related aspects, such as decarbonization targets and the carbon footprint of products and services delivered by Group.




Climate change adaptation

- **Climate risk management**

Identification of climate-related opportunities and risks in line with the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD). The process of identifying, assessing, and managing climate risk is part of the Group's double materiality analysis and overall risk management.

- **Energy efficiency**

Improving energy efficiency across the Group's operations and inclusion of energy efficiency parameters in procurement, particularly when selecting IT equipment and infrastructure, vehicle fleets, and leased office space.



Supporting environmental and climate action

- **Stakeholder engagement**


Strengthening environmental awareness among employees, partners, and fostering collaboration to protect the environment and combat climate change.

- **Regulatory compliance**

Ensuring full compliance of the Group's operations with applicable environmental protection and climate change regulations.

- **Monitoring and reporting**

Regular analysis of environmental performance, publication of reports on climate goals achievement, and implementation of corrective actions when necessary.



Management commitment

The **Management Board** of Grupa Pracuj S.A. is responsible for the implementation and execution of this Policy. It ensures that all actions taken under the Policy align with the Group's long-term strategy and address environmental and climate challenges.

Management teams across the Group's companies support the Policy by integrating its principles into operational processes and strategic decision-making.

To ensure transparency, the Management Board of Grupa Pracuj S.A. is committed to publishing an annual sustainability report that presents progress on the environmental goals defined in the Group's sustainability strategy.

The Group aims to increase the share of energy from renewable sources in its total energy mix by implementing solutions that improve office energy efficiency and cooperating with suppliers offering green energy.




Goal 12 – Responsible consumption and production


Goal 13 – Climate action




Closing provisions
